Student Services and Amenities Fee (SSAF)

2022 Allocation Report

The *Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022* require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This *SSAF Allocation Report* is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this *SSAF Allocation Report* does **not** require auditing by a financial accountant. The SSAF expenditure reporting remains unchanged, more information can be found in the [Financial Statements Guidelines](#) for Table A and B providers, and in the [Financial Viability Instructions: Applicants and Providers of FEE-HELP \(FVI\)](#) for all other approved providers.

SSAF Consultation and Achievements

Consultation

Under the *Edith Cowan University Act 1984* (WA), at least 50% of annual Student Services and Amenities Fees (SSAF) income must be provided to the ECU Student Guild. On 1 June 2022, the University and the Student Guild met to agree the allocation of funding from the SSAF. Prior to this, draft priorities for expenditure of the SSAF funding were published on the student intranet and ECU Student Guild platforms for student feedback, to help inform the effective application of the funding.

The following allocations as proposed by the University and the Student Guild, were endorsed by the Vice-Chancellor on 7 June 2022 and approved by Edith Cowan University Council on 23 June 2023:

providing food or drink to students on a campus of the higher education provider	1.1%
supporting a sporting or other recreational activity by students	19.7%

Compliance

ECU's Finance and Business Services Centre monitors the University's allocation and expenditure of SSAF revenue and provides quarterly reports.

The allocation of 50% of SSAF income to the ECU Student Guild is formalised under a Fees Allocation Deed. In compliance with this Deed, the Student Guild provides quarterly financial reports detailing

their expenditure of SSAF income and a written report detailing their compliance with key performance indicators. The financial reports are provided to the ECU Resources Committee, a subcommittee of the University's Council.

These processes ensure that SSAF income is expended in accordance with subsection 19-38(4) of the *Higher Education Support Act 2003* (Cth).

Achievements and Highlights funded by SSAF in 2022

Some of the SSAF funded activities and services delivered by the ECU Student Guild include:

- A broad range of free or low-cost events including a Guild Fair, International Students Sundowners, Earth Day, Ramadan Dinner and 'open mic nights'
- Health and wellbeing initiatives including mental health first aid training and 'Stress Less Week'
- Second hand bookstore
- A Guild Advisory Service providing advocacy, support and referral services across all ECU campuses.

The SSAF also supported the following activities and services provided by the University in 2022:

- The ECU VolunteerHub that assists students to secure local, national and global volunteering opportunities
- Support to prepare nursing students for their clinical placements
- A Learning Support project run by ECU's Centre for Learning and Teaching providing face-to-face and online support for academic skills development and assistance with assessments
- Sponsorship of students completing in intervarsity sporting events, in addition to free local student sports events.

SSAF Revenue Summary

The following table sets out 2022 allocated and actual SSAF revenue. This includes any SSAF funds carried forward from the previous reported year and any SSAF funds carried over to the next reporting year.

SSAF Charge Summary

The student services and amenities fee charged to students must not be above the maximum fee for a calendar year. The maximum SSAF is indexed annually as required by the *Higher Education Support Act 2003*. In 2022 the maximum SSAF was \$315.

The following table sets out the SSAF amounts which were charged in 2022 and the number of students being charged these fees.

¹ Note: As per Part 2 of the *Higher Education Support (Administration) Guidelines 2022* (Administration Guidelines), students studying on a part-time basis must not be charged more than 75 per cent of the maximum SSAF that a higher education provider determines for students studying on a full-time basis. The term “part-time basis” means a study load of less than 75 per cent of the normal full-time student load for the period to which the fee relates. As per part 7 of the Administration Guidelines, the normal EFTSL value for a full-time student studying over a period of one year is 1.0.

² Note: As per Part 2 of the Administration Guidelines, a higher education provider may choose to determine a different SSAF for particular categories of persons, including a zero amount.

³ Note: Students are categorised as full-time or part-time students based on the total EFTSL value of the units of study they undertook in [insert reported year]. For example, a student undertook a full-time study load in Semester 1 which was equal to 0.5 EFTSL and undertook a part-time study load in Semester 2 which was equal to 0.375 EFTSL. This student would be categorised as a full-time student in [insert reported year] as the total EFTSL they undertook in [insert reported year] was equal to 0.875.


