# Student Services and Amenities Fee (SSAF) 2023 Allocation Report

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this SSAF Allocation Report does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial Viability Instructions: Applicants and Providers of FEE-HELP</u> (FVI) for all other approved providers

### **SSAF Consultation and Achievements**

#### Consultation

Under the *Edith Cowan University Act 1984* (WA), at least 50% of annual Student Services and Amenities Fees (SSAF) income must be provided to the ECU Student Guild. On 30 March 2023, the University, the Student Guild and elected Student Members of University Council met to agree the allocation of funding from the SSAF. Prior to this, draft priorities for expenditure of the SSAF funding were published on the student intranet and ECU Student Guild platforms for student feedback, to help inform the effective application of the funding.

Student feedback collected in 2021 via the biennial 'Student Services and Facilities Evaluation' was also considered by the University in identifying the draft priorities for SSAF expenditure.

The following allocations as proposed by the University and the Student Guild, were endorsed by the Vice-Chancellor on 6 April 2023 and approved by the University Council on 4 May 2023:

providing food or drink to students on a campus of the higher education provider	2.9%
supporting a sporting or other recreational activity by students	19.1%
supporting the administration of a club most of whose members are students	11.1%
caring for children of Students	0.6%
promoting the health or welfare of students	12.1%
helping students obtain employment or advice on careers	19.7%
helping students with their financial affairs	4.0%
supporting the production and dissemination to students of media whose content is provided by students	1.9%
helping students develop skills for study, by means other than undertaking courses of study in which they are enrolled	15.6%
advising on matters arising under the higher education provider's rules	2.8%
advocating students' interests in matters arising under the higher education provider's rules (however described)	5.2%
giving students information to help them in their orientation	6.3%

<sup>&</sup>lt;sup>1</sup> The Guild's bids exceeded their projected SSAF allocation of \$2M by \$55,634. Any shortfall was to be funded by the Guild's reserves.

#### Compliance

ECU's Finance and Business Services Centre monitors the University's allocation and expenditure of SSAF revenue and provides quarterly reports.

The allocation of 50% of SSAF income to the ECU Student Guild is formalised under a Fees Allocation Deed. In compliance with this Deed, the Student Guild provides quarterly financial reports detailing their expenditure of SSAF income and a

written report detailing their compliance with key performance indicators. The financial reports are provided to the ECU Resources Committee, a subcommittee of the University's Council.

These processes ensure that SSAF income is expended in accordance with subsection 19-38(4) of the *Higher Education Support Act 2003* (Cth).

#### Achievements and Highlights funded by SSAF in 2023

Some of the SSAF funded activities and services delivered by the **ECU Student Guild** include:

- A broad range of free or low-cost events including the Guild fairs, Multicultural Festival, Guild Ball, cultural dinners and weekly 'Chillout' sessions
- The Guild Bookshop which benefited approximately 500 students through the sale of discounted second-hand books and book buybacks
- A Guild Advisory Service provided financial, academic and welfare support to over 1,375 students

The SSAF also supported the following activities and services provided by the **University** in 2023:

- Vibrant and informative Orientation Week events to support the transition of new students and foster a sense of belonging
- Careers and Employability services including advisory resources, workshops, careers and industry events and mentoring programs
- The ECU VolunteerHub which assists students to secure local, national and global volunteering opportunities
- Support to prepare nursing students for their clinical placements
- A Learning Support project run by ECU's Centre for Learning and Teaching providing face-to-face and online support for academic skills development and assistance with assessments
- Sponsorship of students completing in intervarsity sporting events, in addition to free local student sports and recreation events

## **SSAF Revenue Summary**

The following table sets out 2023 allocated and actual SSAF revenue. This includes any SSAF funds carried forward from the previous reported year and any SSAF funds carried over to the next reporting year.

### **SSAF Charge Summary**

The student services and amenities fee charged to students must not be above the maximum fee for a calendar year. The maximum SSAF is indexed annually as required by the *Higher Education Support Act 2003*. In 2023 the maximum SSAF was \$326.

<sup>&</sup>lt;sup>1</sup> Note: As per Part 2 of the *Higher Education Support (Administration) Guidelines 2022* (Administration Guidelines), students studying on a part-time basis must not be charged more than 75 per cent of the maximum SSAF that a higher education provider determines for students studying on a full-time basis. The term "part-time basis" means a study load of less than 75 per cent of the normal full-time student load for the period to which the fee relates. As per part 7 of the Administration Guidelines, the normal EFTSL value for a full-time student studying over a period of one year is 1.0.
